1 Limonene

A monoterpene with a fragrance that can be described as orangey, citrusy, sweet and tart. It is most commonly found in nature as D-Limonene and is a primary contributor to the distinct scent of orange peels, from which it is commonly derived. Found in numerous pines, red maple, silver maple, aspens, cottonwoods, hemlocks, sumac, cedar, junipers...etc.

2 p-Cymene

A monoterpene with a fragrance that can be described as woody and citrusy. Found in Ajowan, allspice, angelica, basil, bay leaf, bergamot, blackberry, cinnamon, clove oil, dill leaf...etc.

3 Myrcene

A monoterpene with a fragrance that can be described as peppery, spicy, herbal, floral and woody. Although it has a pleasant odor, it is typically used by the perfume industry as precursor for developing other fragrances. Found in hops, houttuynia, bay, thyme, lemon grass, mango, verbena, cardamom, citrus...etc.




