2 Isopulegol

A monoterpenoid with a fragrance that can be described as woody and minty. It is also a constituent of toxic secretions of exploding ants. Found in eucalyptus, rosemary, citrus, lemonverbena, micromeria, lemon balm...etc.

Borneol

A monoterpenoid alcohol with a fragrance that can be described as fresh, piney and woody. Found in forskohlii, rosemary, coriander, Scotch pine, blackjack, ginger, oregano, savory, feverfew, rose gum, Aztec marigold, pennyroyal, sakhalin fir...etc.
